- 2. Send the duly-filled application form to 'The Director, Rajiv Gandhi Centre for Biotechnology, Molecular Forensics & DNA Technologies, Poojappura, Thycaud P.O., Thiruvananthapuram-695014, Kerala, India'.
- 3. All applications shall be scrutinized and soft copy of primer details (if applicable) should be sent along with the application.
- 4. Total cost for the analysis should be paid in advance either as DD drawn in favor of **The Director, Rajiv Gandhi Centre for Biotechnology** payable at **Thiruvananthapuram** or in cash at the MFDT cash counter.
- 5. Samples will be processed on receipt of payment only. All payments are 100% non refundable.
- In all correspondence, the envelope should be superscribed in bold letters as ,MFDT -APPLICATION FOR DNA FINGERPRINTING/BARCODING SERVICES'.
- 7. Samples Rejection Criteria:
